**Agreement for Academic Scientific and Cultural collaboration between the  
FUNVIC UNIVERSITY CENTER - UNIFUNVIC (BRA)  
& SPORT ACADEMY (BEL-UAE)**

To strengthen the academic, scientific and cultural ties between the two Institutions, the Honourable Professor Luís Otávio Palhari, Rector, on behalf of the **FUNVIC UNIVERSITY CENTER - UnifUNVIC maintained by Christian Life University Foundation**, registered with CNPJ/MF 07.761.666/0001-01, headquartered at Estrada Radialista Percy Lacerda, nº 1.000, Bairro Pinhão do Borba, in the city of Pindamonhangaba, in the State of São Paulo, in Brazil, accredited by Ministerial Ordinance nº 1.270, called Institution of University education, of the Brazil and Professor Igor Lanzoni, CEO, on behalf of the **Sport Academy**, registered with vat. Number 0755543193, headquartered at Rue Joseph II, nº 40 B - Avenue Henri Jaspar, nº 113 - 1060 - in the city of Bruxelles, in Belgium, hereby agree to establish the following Academic Co-operation Agreement:

**Clause 1:**

Both Institutions agree to promote joint academic, scientific, and cultural endeavors and foster cooperation between its undergraduates and graduates' courses, departments, Institutes and research centers.

**Clause 2:**

Both Institutions agree to cooperate in all the areas of mutual interest and research programs.

**Clause 3:**

Within this framework, both institutions shall cooperate in the following activities:

- 1- Joint research activities in areas of mutual interest to both Institutions.
- 2- Exchange of information in areas of mutual interest to both Institutions.
- 3- Exchange of professors, researchers and students to carry out joint projects in the fields of cooperation that are established.

**Clause 4:**

Both institutions agree to negotiate annually the possible exchange of students pursuant to the clause

3.3 of this Agreement. In order to do this, both institutions will exchange information at least six months prior to the beginning of the exchange period. This information shall specify the activities to be carried out and the means of co-operation, as well as their duration, dates, number of participants and whatever details are needed, taking into account reciprocity.

**Clause 5:**

Every joint project concerning this Agreement will be developed and put into practice by means of an Appendix in which all the details about the particular activity will be specified.

**Clause 6:**

The economic conditions of the exchanges will be met, in each case, subject to the parties' budgetary considerations.

In any case, both institutions agree to seek external financial resources, both from public and private institutions

**Clause 7:**

The Sport Academy will be an operative branch and educational service provider of UniFUNVIC in Europe and Asia. Sport Academy will organize a special University Degree in Physical Education, Motor Science and Masters in Sport Management in partnership and cooperation with UniFUNVIC. The final and official diplomas will be issued by Sport Academy and registered in UniFUNVIC. The curriculum carrier of students and educational credits will be recognized by UniFUNVIC and also in the Universities partner of Sport Academy, the equivalent educational action plan will be for the UniFUNVIC students.

**Clause 8:**

The UniFUNVIC appoints the Prof. Antonio Imeneo as the responsible of Europe of FUNVIC UNIVERSITY CENTER - UniFUNVIC and who will coordinate the activities referred to in this agreement.


**Clause 9:**

The present agreement will come into effect on the day of signing, once it has been approved by the proper authorities and will continue for a period of four years.

The agreement may be renewed for periods of equal length by expressing prior agreement and in writing by both parties.

The details of the partnership's activities must be carried out through addendum terms to the agreement.

Modification or termination of the present agreement can be requested by either party, by way of written notice to the other party, with minimum of three months' notice, without detriment to previously coordinated activities and will be resolved by joint agreement.
